#### Be Clear and Precise


Vagueness can lead to misunderstandings and disputes. Be specific about:

#### Choose the Right Executor

are declared invalid. Also make sure that your will is dated. Although this is not a legal requirement, it ensure that the latest will can be identified.

#### Safeguard Your Will

Once you have signed your will, make sure you keep it in a safe place, that is accessible to your executor, and inform your executor where to find it. It is best not to hide it in places no one can access or locking it away without sharing a key or password.

#### Be Careful of DIY Mistakes

There are many online will templates available and it is tempting to use them to avoid expenses, but small error can have



major legal consequences. Rather make use of a professional will drafting service to ensure that your will is correct and valid and clearly state your wishes.
